

Terms and Conditions

Conference Registrations:

Early reservations are recommended since our group size is limited – airline/hotel blocks are limited and often sell out of their best fares/rates months in advance.

Prices are quoted in euros and will be converted to U.S. dollars at the time of full payment. Initial deposits required are due in USD. (You will pay Hotel Splendid & Spa directly in euros.) We accept VISA, MC, AMEX, Discover, ACH or wire transfers. If you are paying by credit card, the charge will appear on your billing statement as payable to ***Opportunity Travel***.

Single Supplements:

Unless otherwise noted, accommodations are based on double occupancy. Participants who specifically request single accommodations must pay a single supplement. If you are traveling alone and wish to share a room with another participant, we will try to find a roommate for you although we cannot guarantee a match. If a roommate becomes available, we will issue you a credit.

Cancellation Policies:

Nice Conference Only: If you decide to cancel your conference registration you must advise us in writing via email sent to info@opportunity-travel.com. You may also leave a voicemail message, but it must be followed up with a written cancellation.

If you cancel your Nice conference registration you will be subject to the terms and conditions of the cancellation policy below—which can also be found in your confirmation email once registered.

- Cancel from date of booking through August 1, 2021 – refund less a \$100 fee per person.

Cancellation by *Opportunity Travel & Events* and *Adrian Leeds Group*:

If we are forced to postpone this conference and/or tour to a later date, we will move your reservation to those new dates. If the new dates do not fit in your travel plans, we will fully refund your registration fee back to the original credit card used when registering.

If we have to cancel this conference and/or tour due to unforeseen circumstances, **we will fully refund your registration fee back to the original credit card used when registering.**

If you have incurred other expenses due to the postponement or cancellation, such as hotel reservations, airline tickets, etc., you will need to seek a change of date or refund via that entity.

Opportunity Travel & Events (OT&E), reserves the right to cancel any trip prior to departure for any reason whatsoever, including insufficient signup or logistical problems that may impede trip operations. Responsibility & Limited Liability:

Your payment represents your acceptance of the following terms and conditions:

(OT&E) reserves the right to substitute both trip leaders and hotels from those listed in our promotion without notice.
